

# 2010 Camp Scholarship Application Packet

Dear Parent/Guardian:

Thank you for your interest in Girl Scout resident camp scholarships. In these difficult economic times, we would like to be able to award scholarships to everyone who applies. This is also a difficult time for nonprofits. We will do our best to ensure every girl who wants to go to camp has the opportunity.

Please carefully read and follow the application process. *Your scholarship eligibility will not be reviewed until all application documents are received.*

## Camp Scholarship Application Process

Please provide the following:

1. Confidential Scholarship Application.
2. Completed Registration Form for camp program must have been submitted, with required deposits. *If we are unable to award a scholarship, and you are unable to send your child to camp without a scholarship, your deposit will be refunded upon notification from you. Please notify us in writing at least four weeks before the start of the session you are cancelling. If your daughter does not attend camp and four weeks' notice in writing is not given to the Girl Scout office, you will be responsible for the full camp fee.*
3. Scholarships are available for one session of summer camp per child, per summer. They are based on financial need, Girl Scout membership, participation in the 2010 cookie sale, extenuating circumstances, the total number of requests, and total money available.
4. Documentation of Income:
  - Copy of 2009 tax return (W2's alone are not enough to make an award)  
OR
  - Other documentation of income (i.e. current social security benefit, disability check, DHR statement, or food stamp award) in lieu of 2009 tax return if you do not submit a tax return.
5. **Return to either location by Friday, April 23, 2010.** Applications may be mailed, e-mailed or hand delivered.
