Due to the high request rate, full scholarships are not awarded. Camp scholarships are available to **pay a portion (10-75%)** of the camp fee for girls that would benefit from the camp experience and would not be able to attend camp otherwise. Failure to pay remaining fees on time will result in the loss of scholarship. The review committee makes every effort to distribute available money fairly to assist as many girls as possible.
