# Online Sales



- •Girl Scouts create their personalized storefront in M2 and send emails to friends and family.
- ·Customers order and pay online.
- •Orders are automatically credited to the Girl Scout in M2, and the items are included in the troop order.

#### **MUNCHIES & EXTRAS // DIRECT-SHIP**

- •Customers online payment includes shipping cost.
- •Shipped directly to the customer, 1-2 weeks standard delivery time frame after order processing. Customers will have the option for expedited shipping.

#### **MUNCHIES // GIRL DELIVERY**

•No delivery cost for customers. Girl Scouts receive product at the end of the product sale and arrange delivery to customers.

#### MAGS // ONLINE ONLY

- •Customers can purchase new subscriptions and renew existing subscriptions.
- •Shipped directly to customer, 6-8 weeks standard delivery time.

# In-Person Sales

- •Girl Scouts record orders on their nut card and collect money from customers.
- •Family enters orders into M2 by the appropriate deadline.
- ·Girl Scouts turn in money to Troop.
- •Girl Scouts receive product at the end of the product sale and arrange delivery to customers.
